COVID-19 Information and Guidance

Background information on how events developed over the past week:

- Over spring break, we knew there were going to be concerns with travelers coming back from all over the world. This concern was compounded by the cancellation of national events, MSHSL state tournaments, etc.
- At the Governor's press conference on Friday, March 13, we expected the Governor to close schools. When he didn't, we decided to close school Monday and Tuesday. On Sunday, the Governor closed schools from March 18-27. The purpose of the closing was to prepare for distance learning which will begin on March 30. In addition, beginning on March 18, schools began providing childcare for health care professionals, meals for qualifying families, etc.
- We sent out survey to staff to get feedback on how they felt about coming back to work, their comfort level, their concerns, etc.

- Monday, March 16 there was an all-staff meeting with division meetings following.
 These established common knowledge and steps to move forward through the week.
- Currently administration and staff are working on publishing a distance learning plan to address specifically attendance, daily instruction, interaction with teachers on a daily basis, etc. This involves ensuring equity so all students receive instruction and interaction with the Prep team.
