#### Status of 2020-2021 School Start & Learning Model Discussion

Washington County case rate has increased to above 20 which means tighter restrictions on room capacity, physical distancing, etc. The start of the school year brought a few challenges: power outage on the first day, technology issues, etc. Food service has been working hard to bring free meals for any family who requests them. Majority of students are currently in the hybrid learning model (75-80%) – administration will push for improvements to student learning model to the end of the quarter.

Principals summarized where their divisions are at currently:

- LS teachers are happy to see kids again, students are only leaving the classroom for recess and PE, teachers are working hard/doing their best
- MS getting back into a routine has been good, teachers are fiercely passionate about teaching however burn out will happen
- US the past week is not necessarily a fair assessment of how it is going, there are lack of social distancing issues; students will be reminded of our new protocols.
- SPED staff is spread very thin, staffing is logistically nightmare

Because of quarantine and isolation requirements, this will be the biggest impact to remaining on course for hybrid learning. Like students, any staff with Covid-19 symptoms must stay home from school until quarantine period is over or they have been cleared via testing or physician diagnosis.

School board is going to survey the parents and staff to see how the school year is going for them and how the learning models are working. Survey will be sent out with results back in time to discuss them at the October 6 board meeting.
