Who can vote in this election? SCPA defines a "Voter" as:

- <u>All Employees.</u> All employees (e.g. administration, faculty members, educational assistants, food service, etc.) excluding employees contracted via external organizations;
- <u>Parents/Legal Guardians.</u> All parents/legal guardians, with a limit of two votes per family.

#### Why are you interested in serving on the Board of Directors?
